Important information on the buy/sell spreads of JANA Investment Trusts

This document is issued by MLC Investments Limited, ABN 30 002 641 661 AFSL 230705, ('MLC') as responsible entity of the trusts listed in Annexure A (each a 'Trust'). This document contains updated information for the JANA Investment Trusts Information Memorandum ('IM') in respect of each Trust which was issued on 16 October 2020.

Before making a decision to invest in the Trusts, you should read this document in conjunction with the IM, and in particular the section of the IM that provides information under the heading 'Buy/Sell spreads'.

Updated buy/sell spreads

With effect from 26 October 2020, the buy/sell spreads that apply for each Trust are set out in Annexure A.

Buy/sell spreads are incurred when investors apply for or redeem units in the Trusts. They reflect the transaction costs associated with the purchasing and selling of assets within the Trusts in order to issue units or pay redemption proceeds to investors. The application of buy/sell spreads to the Trusts ensures fair attribution of costs between transacting and non-transacting investors. Buy/sell spreads are not fees paid to MLC.
